



Our ESL students were impacted by COVID-19. We spent a lot more time on the "MORE" instead of formal

English or Bible lessons. We made several attempts to meet, but it was always stop and go... complete with masks and social distancing. This sums up the things that the students struggled with this past year.

Difficulty in understanding folks with masks
Loss of work or having to work from home
School at home on the computer which was very difficult
Travel plans cancelled, delayed, or altered
Covid cases in their families
Hospital stays / surgeries / therapy
Miscarriages / funerals
Broken bones / car accidents
Quarantines / depression
Vaccines (some with reactions)
Unable to find workers for their businesses
Anxiety issues because of the anti-Asian atmosphere

I am proud of how some of the ESL folks reached out to help others during COVID. One went daily to a senior adult center to help make meals to be delivered to the elderly. One volunteered to work at two different vaccination sites to help register folks. Several filled shoe boxes for Operation Christmas Child. One student was asked to serve on a committee to help a school make decisions concerning COVID issues. I was able to do a one-on-one Bible study online with a student.

I thank God for being able to remain in contact with the students through social media, calls, texts, e-mail, and snail mail. I was able to reconnect with some former students as well. We finally had the pleasure of meeting together for a meal at a restaurant or a home visit when the students felt comfortable doing that.

We are finally able to meet more like a "normal" semester with masks being mandatory inside. We were able to hand out hotdogs on campus during the first week of class. On Thursday August 19th, we served the students a quick lunch and handed out flyers about our Bible Study taking place on campus. We had several good conversations with two students who started attending the Bible Study the very next week.

Every Thursday we have Bible Studies that start at 11 am and 12:15 pm in Room 140 of the MSA building. This allows us to reach more students as they have different breaks during the day. We have been having half a dozen to a dozen students at each Bible Study. We hope and pray to see that number grow as more and more students find out about the study. We are going over "Your Time is Now" by Jonathan Evans. We can supply the students, for free, access to Right Now Media through our BCM. This allows the students to keep up with our current study and be able to access many more online through Right Now Media.

Our group did attend a Registered Student Organization meeting on campus where we were able to meet the new Calhoun Community College president, Dr. Jimmy Hodges. Our relationship to the administration is going very well and they include us in as much as possible. We hope to get our BCM students involved with intramural activates as they take place throughout the semester.

For our ministry projects this semester, our goal is to have our BCM fill three backpacks with our students. We also are hoping to get Chick-fil-A help us to fill a couple more as two of our students work at Chick-fil-A. We are also teaming up with Students for Life to gather diapers and other supplies for first time parents to be given away through Sav-A-Life of Decatur.

Thanks for your prayers and financial support of the ministry of BCM at Calhoun-Decatur. We could not be on campus and be effective without your backing and prayer support. We would especially pray for one of our students who has been attending Bible Study because he wants to "check out the Christian point of view" as he is looking into different religions. (October, 2020 - September, 2021)

We had an active year for the Disaster Relief Team. We worked on 40 different activities, involving 166 volunteers. Highlights for the year are:

- October Chainsaw team to Robertsdale, AL (Hurricane Sally)
- November Chainsaw team to Thomasville, AL (Hurricane Zeta)
- March Feeding team to Jackson, KY (Eastern KY flooding)
- May Chainsaw team to Priceville, AL (storm damage)
- July Feeding team to Hartselle, AL (lunches for Serve Day)
- September Assessment and Admin teams to Louisiana (Hurricane Ida)

Preparation and training are ongoing efforts to be ready to respond in various disaster areas, such as chaplains, cooks, chainsaw, cleanup, administration, HAM radio communications, or shower/laundry. The Disaster Relief team appreciates the support received from a number of churches in the association.

Associational WMU/Women's Ministry 2021 Annual Report

An Associational WMU/Women Ministry meeting was held on April 29, 2021, to discuss our goals to support the ministry of the Morgan Baptist Association and the growth of mission groups and organizations for women and children in our county. We discussed plans for the upcoming year and specifically the first event scheduled for June 2021, which was the Swamp John's Dinner event to raise funds for MBA maintenance and repair expenses. The Swamp John's dinner was held on June 18, 2021, at the associational office and with the help of numerous volunteers from the Disaster Relief team and churches through the association were able to raise approximately \$2,000.

A WMU Ladies Missions Night was held on September 20, 2021, at West Hartselle Baptist Church with approximately 30 in attendance. Our speaker, Ms. Robin Janney, shared about her mission work and led the group in making gifts for the pastors' wives in Wyoming as part of our association's partnership with the Wyoming Baptist Association. As a ministry to provide support and encouragement, cards and small care packages will be sent to the pastors' wives over the next several months.

May I express what a wondrous privilege it is to serve as the President of our Morgan Baptist Association Pastor's Conference. It is with sincere gratitude that I extend my appreciation to all our MBA pastors for allowing me to fulfill this role.

The global pandemic we have dealt with over the past couple of years has left most pastors discouraged, doubtful, and downtrodden as they reflect on what church previously looked like in comparison to the present. Declining attendance and lack of involvement leaves churches scrambling for assistance, attempting to fulfill roles of individuals who were once faithful but are currently "missing in action", and presently pastors are standing without any inclination as to what the next step may be. My dear brother, you are not alone. Friends of mine from congregations of 15 to 7,000+ are struggling with the same difficulties. In Morgan County, I want you to know that all these brothers are in your corner to support, encourage, and stand with you during this unprecedented season.

This very reason is why our format has transitioned in our pastor's conference. As a pastor, you probably remember receiving an invitation from myself or our Director of Missions to come and preach to our association pastor's conference. Although hearing a speaker can educate and encourage us as ministers of the Gospel, the need became evident that this was insufficient. All adversity can work for good, Paul informed us of that, and you have witnessed this also during the pandemic as it assisted you in making numerous difficult yet necessary transitions.

Collectively, we came to a conclusion which spawned a greater idea. We are now striving to foster an environment of encouragement, education, and enthusiasm, accomplishing this through the removal of an itinerant speaker calendar and implementing a time which we glean from one another, pray for one another, and encouraging one another. We pushed our tables together, brewed some extra coffee, and decided that we could learn from and encourage one another sufficiently by discussing the joys and perils of ministry. Our numbers have increased, new men have joined our fellowship from other counties, missionaries have been visiting with us on a frequent basis, and a spirit has revived itself within our meetings which is unexplainable. I must add, for a young man in ministry, this time of fellowship on Monday mornings has proven to be necessary as I seek to make the correct steps in ministry.

I am no prophet, nor do I claim to be one, but until a bump arises in your ministry, you will never understand the importance of men of God who gather to pray over you and your ministry. Learning from those who have been where you are going, are enduring what you are currently enduring, or are hoping to experience what you have experienced, pastors become your ministry's greatest tool. I have yet to see a lifeway publication or ministry resource provided from any board or organization that provides as much information, encouragement, and guidance as these men of God do. I understand the importance of your staff meetings, ministry tasks, and necessary correspondence, but fellowshipping with other men of God is irreplaceable.

I am extending the invitation to you as a pastor to join us on Monday mornings at 10:30 a.m. in Hacker Hall of the associational office as we each strive to minister together. At the conclusion of our

Director of Missions and Ministries Report to Annual Meeting 2021

Welcome to the 102nd Annual Meeting of the Morgan Baptist Association! It is hard to believe that another year has already passed. After a difficult 2020, we were excited to begin this year of ministry and partnership. Although the effects of COVID19 have continued this year, our churches have been able to respond and adapt in many ways.

Just like our churches, we have been aiming at a moving target in trying to continue our ministry activities in the midst of the ongoing medical situation. Thankfully, we have been able to keep our doors open and most of our ongoing ministries intact. Things have been slow this year, and sometimes alarmingly so. Our on-site ministries at the Caring Place and Sycamore Bargain Center have seen steady opportunities to minister to our community thanks to our wonderful volunteers! The front office has had limited foot traffic but we have continued to use the facility as a gathering place for the Gideons, our pastors and ministers, MTI (Ministry Training Institute) students, Sunday School classes, PEN (Pastor Enrichment Network), Disaster Relief and various other MBA committees and teams.

Due to the uncertainty that was characteristic of 2020, we had postponed some needed repairs on our facility. This year our Trustees have begun a program of repairs and improvements for issues that had turned into urgent needs. We are grateful for the positive and generous response of our churches, individual members, and even friends of the association who have donated money and/or labor toward getting some of these things taken care of. Together, we have been able to refresh our outside shrubbery areas, repair a broken fence, begin replacing our indoor lighting that has been a constant problem, and several other relatively minor repairs needed to keep us operating. Much more needs to be done.

We have had a continuing challenge getting our mission plans back on track. The uncertainty of overseas visas and travel requirements have made it difficult to get commitments for organizing these kinds of trips. We do have some who have shown interest, and we are hoping that more will be willing to make commitments in the near future. We have also been blessed to host several missionary families at our associational ministers meetings and our monthly PEN meetings. It is great to get to know our missionaries and to support them with our encouragement and our prayers. Our MBA WMU recently hosted an event that featured a missionary wife from Mexico as the speaker. We have also met and fellowshipped with missionaries serving in India, Germany, Uganda, Zambia, Indonesia, and China. We have also supported local outreach ministries by being involved in various Bible studies, community activities, and training opportunities. We are hoping to be able to put together volunteer teams to serve here in the US and perhaps in some of these places overseas in the upcoming months.

Another area we would like to focus on is church planting among our Hispanic community here in Morgan County. We are told that there is great need for solid, Bible-believing churches among this growing community. We continue to pray and look for opportunities in this ministry area.

One thing that has not changed is our commitment to pray for our pastors and encourage them however we can. Our pastors are learning how to minister in a culture that is now post-Christian, even here in the so-called "Bible Belt". The church, though comparatively strong where we live, is sadly compromised, often divided, and under attack by practically every other institution in our society. That means that pastors are trying to lead, serve, preach, and minister in a more hostile environment than before. They meet skepticism, cynicism, and criticism at every turn. Except from their church family when that family is biblically grounded, righteously motivated, and prayerfully committed! Your pastor needs your encouragement, respect, love, and especially your prayers! Our association is committed to encouraging our pastors and to praying for them. Our office staff sponsored a Pastor Appreciation Brunch in September as a way to recognize those who minister in our association.

Unfortunately, Pathways Christian Counseling has not replaced Neill Hunter who retired this past year. We remain hopeful that another on-site counselor will be assigned to us, but there are no immediate plans to do so. Meanwhile, our office can still help your church connect with counselors in Decatur, Athens, or Cullman. Thankfully, one of our other ministries has finally been able to resume after almost two years. Raceway Ministries missed three races at Talladega during the pandemic, but finally was able to minister to race fans at Talladega this Fall. Also, our Disaster Relief Team, WMU, and VBS Team have been able to do as much or more this year than last. We are hoping 2022 will be even more open and that we can resume and improve some of these and other ministry activities and plans.

I want to thank you very much for your continued prayer and financial support for these critical partnership ministries through your association! Our association's success in ministry and our service to the Lord Jesus through its ministries are limited only by our vision for partnership, our financial support for that vision, and our participation in carrying out that vision together. I trust that you and your church will continue to partner with your association as we seek the vision together, provide the necessary resources, and participate together toward its fulfillment in this coming year!







Alabama Baptist Children's Homes & Family Ministries (ABCH) 2021 Report

In our homes across the state, we are blessed to see God working and transforming the tender hearts of so many of our children and teenagers. We see Him at work in both small and big ways, and we know as Kingdom partners in this work with us, you too, will celebrate how God has been at work in these young lives this year:

Brothers, Nick* & Andrew*, adjusted well in school, performing above average in academics and stayed committed to the football team, despite a tumultuous family life.

We saw Deon*, who had been with us for over three years, able to be reunited with his father. This is a miracle and praise, and also a prayer request. We ask that you pray for this family and other families like them, as they reunify and transition to life together again and that parents and relatives will maintain all they need to do to keep their families healthy and intact.

Wes* followed the Lord in Believer's Baptism. He was saved several years ago but had never had the courage to be baptized because one of his closest family members is very hostile to the Christian faith. Our house parent shared this wonderful news of his baptism, saying, "Only God could've given him the courage to overcome those fears."

When teenager Maggie* first came to us, she barely held her head up when she would speak to you. She had very few life skills. She did not know how to take care of herself in regard to simple hygiene habits that most of us learn as children, and she was failing in school. But after being in our care—being consistently loved, protected, and nurtured—things began to change in Maggie's life in the best ways.

First and most importantly, she accepted Christ as her Savior! Over time, we've seen her grow to be very health conscious and very well kept. She began to make A's, B's and C's in school and is well respected by her teachers and peers. Finally, this shy little girl who barely uttered a word, tried out and made Color Guard at her high school. She continues to grow in her faith and tells her friends at school about Jesus.

2020 was certainly a year like none other, but we praise God that He still faithfully worked in thousands of lives through your Children's Homes. Looking back at 2020, your support helped us care for 4,443 people across all areas of ministry, serving 382 in our Foster Care homes, 105 in our Campus and Shelter Care homes, 93 in our Family Care homes, and 3,758 through our counseling services! We are thankful to the Lord for 15 professions of faith in 2020, 42 new homes licensed for foster care, 35 adoptions, and 130 reunifications to family members!

Your support of children from hard places is invaluable to the work God has called us to do. Thank you. Every day in our ministry, lives are being influenced and impacted for the Kingdom. Thank you for praying, serving, and giving as we work together to protect, nurture, and restore children and families through Christ-centered services. We are so grateful for what God has done and look forward to all that He has in store!

2021 Woman's Missionary Union Annual Report

Truly this past ministry year has been like none that any of us have encountered. Yet, during some of the most challenging and difficult circumstances Alabama Baptists rose to the occasion and persevered in staying true to making the name of Jesus known!

Members of Woman's Missionary Union (WMU) while working alongside their pastors persevered and when many of our churches had to shut down due to the pandemic, put into action their call to missions.

When mission discipleship groups were unable to meet in person, many began to find ways that they could love on their neighbors through prayer, provision of basic needs and encouraging notes. In addition, these groups found ways to gather via online programs such as Zoom, Microsoft Teams, and Facebook Messenger. Others prepared missions discipleship lessons for their preschoolers and children and delivered them to the homes of students. While the pandemic has been heartbreaking and challenging, it has also forced us to look beyond our normal and find new ways to engage our Alabama Baptist churches for the cause of missions.

Alabama Woman's Missionary Union was called upon to assist missionary families that found themselves reassigned to the United States for a time as the world determined the best way to handle the pandemic. During this time, they assisted in helping to find housing and met other needs. Capitalizing on this unique time in history, they began offering Zoom gatherings entitled "Great Commission Conversations" that allowed Alabama Baptists the opportunity to meet our mission personnel, get to know them personally and learn how to pray and support their work. To date 54 gatherings have been hosted.

In addition, to meet needs of our Ministers' Wives, Alabama WMU created a Zoom gathering for ministers' wives entitled "Ministers' Wives Connection". These gatherings meet monthly and offer a place of prayer and encouragement for these servants.

Encouragement was also offered for missions discipleship leaders and women's ministry leaders through Zoom gatherings and leadership training offered online. These touch points became important to our leaders as we all attempted to minster to one another and reach our communities during this unusual time in history.

Much concern was expressed about the continued support of our mission personnel through this time. Alabama Baptists stayed true to supporting our missionaries through their giving and praying. Support through giving to the Annie Armstrong Easter Offering, Lottie Moon Christmas Offering and Myers-Mallory State Missions Offering remained strong even in this time when many were without employment. Giving through the Cooperative Program during this time was also unprecedented.

Spring 2021 in-person gatherings resumed as did Alabama WMU's missions events. These events were hybrid events, meaning there was a small in-person group as well as a digital option.

WorldSong Missions Place, the camp owned and operated by Alabama WMU, was shut down during the year as well. However, this did not stop missions camping. The summer of 2020 missions camping was offered online, and the summer of 2021 missions camp was taken to the local church and associations.

Praise the Lord for His goodness, strength and wisdom which has guided us all to persevere during this challenging time and allows us to look to the future of missions with great hope!

2021 Report to the Associations

The Board of Directors and staff of The Baptist Foundation of Alabama (The Foundation) are pleased to present this report to the associations of the Alabama Baptist State Convention. This year was a time of change for our ministry, as we celebrated the retirement of our President, Barry Bledsoe, after 20 years of excellent service. John Ashworth, our Chief Administrative Officer since 2014, became President on June 19, 2021. While our leadership has changed, our commitment to serve Alabama Baptists remains the same...in every service we offer, resource we provide, investment we make, our heart is to make Him known. It is The Foundation's privilege to help churches mobilize resources for Kingdom purposes through our various ministry services:

Legacy Launch – Every year, we equip dozens of churches, just like yours, to offer a Legacy Ministry to their members. Since 2010, 1,000+ families have completed Legacy Planning, resulting in approximately 300 million dollars in future Kingdom gifts. This past year, we created Legacy Launch – a framework to help new and existing Legacy church partners clarify their message, cast their vision to their people, and build a sustainable Legacy Ministry into the future!

GiveThree65 – The Foundation moved quickly when the uncertainty of the pandemic arrived and partnered with The Alabama Baptist State Board of Missions to launch GiveThree65 – a digital giving platform. Created within days of Alabama's lockdowns, we helped over 70 churches put plans in place to move giving online. By offering multiple ways to give, you will empower your members to practice generosity anytime and anywhere.

Kingdom Impact Investing – Providing investment solutions, managed in a Biblically responsible manner, is yet another way we tailor our services to meet the unique needs of your ministry. We exclude investments that do not align with your faith, and include investments that further Kingdom work, while seeking to earn a compelling market return. We reacted to the volatility of the last year by striving to allocate assets prudently while aligning clients' investments with their objectives and their faith.

Educational Scholarships – As the pandemic disrupted campus life and classes moved from in-person to virtual, The Foundation continued supporting the educational goals of the next generation of Christian leaders. Almost \$500,000 was awarded directly to colleges and seminaries to support their missions. In addition, through over 100 scholarship funds, another \$575,000 was awarded to Alabama Baptist students. These generous scholarships propel today's students to become tomorrow's Christian leaders.

Vision Campaigns – In 2020, The Foundation began offering coaching for Vision Campaigns – a holistic stewardship and generosity ministry initiative. These campaigns allow your congregation to give beyond their regular tithe to additional expansion projects that help further your church's ministry. Capitalizing on our team's experience in coaching churches in stewardship and generosity, The Foundation's Vision Campaigns have already begun helping Alabama Baptist churches.

Alabama Baptist Historical Commission 2021 Ministry Report to Associations Unveiling the past to enlighten the present and illumine the future.

The Alabama Baptist Historical Commission is dedicated to preserving the record of God's faithfulness to His people called Alabama Baptists. Alabama Baptists' gifts through the Cooperative Program support ministries of the ABHC that challenge, encourage, and equip Alabama Baptists to collect, preserve, share, and promote our rich story and heritage.

Collection and preservation of original records are important ministries of the ABHC. The best way to preserve the information in historical records is by microfilming, which ensures that Alabama Baptist history will be maintained regardless of natural disasters or unexpected tragedies. The ABHC microfilm ministry is offered free of charge to all Alabama Baptist State Convention churches, associations, entities, and the convention. Pick up and return of records is also provided at no cost. Last year, more than 40,000 pages of Alabama Baptist materials were preserved through our microfilm ministry.

In addition to collecting and preserving our history, it is important to share the story of God's Alabama Baptist Great Commission people. One way to share our story is through the ABHC's ministry of planning, facilitating, and conducting tours of the Alabama Baptist Historical Collection and other resources of historical significance and interest. Due to Covid restrictions, we were unable to do tours for church or association groups in 2020.

Anniversaries are important times of celebration and remembrance in the lives of Alabama Baptists. The ABHC assists with celebration planning for and presents recognitions to churches, associations, and Alabama Baptist entities celebrating milestone anniversaries. Last year, the ABHC celebrated 39 milestone anniversaries through presentations of framed certificates or letters of commendation.

For the fourteenth consecutive year, the ABHC served in all 75 Alabama Baptist associations. The staff conducted 19 workshops and presentations for churches and associations on highlights of Alabama Baptist history, anniversary celebration planning, records collection, preservation, and management, writing of church and association history, setting up church archives, and oral history interviewing in 2020. The ABHC also presented and/or displayed at several state and association events either by video conference or in person.

In 2020, the ABHC made available several publications including: Children of Light, a historical coloring/puzzle book, A Miracle of God, the memoir of Dr. Troy Morrison, former Executive Secretary of the Alabama State Board of Missions, Every Day with Jesus, the memoir of Jane Ellen Gaines, a missionary to Nigeria, My Day, the memoir of Dr. H.O. Hester, a state missionary who served in the area of racial reconciliation, and an instructional brochure series. The ABHC delivered information packets throughout the state containing materials helpful to churches and associations in preserving their history. The ABHC website, www.abhconline.com provided information regarding upcoming anniversary celebrations, tour groups, and ABHC presentations and ministries.

The ABHC added approximately one hundred church photographs to its survey of Alabama Baptist churches, which preserves the visual record of our Alabama Baptist places of ministry and worship in 2020.

LEGISLATIVE MATTERS: Alabama has always been considered a very socially conservative state, but the 2021 Legislative Session was an embarrassment as legislators in both houses passed a number of socially liberal bills.

Alcohol

Since becoming a "super majority," Republican lawmakers have demonstrated that they have never seen a beverage alcohol expansion bill they did not like. This year was no exception. A series of bills were passed and signed into law by the Governor that legalize direct shipment of alcoholic beverages to the homes of Alabama citizens. While the bills included requirements for delivery personnel to check IDs to make sure the person receiving the shipment is 21 years of age or older, ask yourself if you think FedEx or UPS delivery personnel will consistently do that. It is not likely.

"Medical" Marijuana

In spite of heroic efforts by several members of the Alabama Senate and the House of Representatives to stop its passage, the "medical" marijuana bill (SB46, sponsored by Sen. Tim Melson) passed both houses and was signed into law by Governor Ivey. We are disappointed, but we will do everything we can to keep marijuana legalization from continuing to expand. In many states where "medical" marijuana has been legalized, the legalization of recreational marijuana has often followed.

Yoga

Yoga is intrinsically tied to the Hindu religion and for that reason has been banned in Alabama public schools (K-12). But that is no longer the case. The Alabama Legislature has now voted to allow a Hindu religious practice to be taught in public schools.

Vulnerable Child Compassion & Protection Act (VCAP)

This bill passed the Senate, but leadership in the House refused to allow the bill to come to the floor of the House for a vote. This bill would have prohibited hormone blockers and surgical procedures to be used on children for the purpose of changing their birth sex, before being old enough to decide for themselves.

"Born Alive" Bill

One bright spot was the passage of the "Born Alive" Bill, sponsored by Rep. Ginny Shaver. This bill requires that medical staff do everything possible if, during an abortion, a child is born alive. This bill received bipartisan support in both the House and Senate. We applaud Rep. Shaver for her persistence in getting this bill passed into law.

Gambling

For ALCAP, the biggest issue during the 2021 Regular Session of the Alabama Legislature was gambling. Several gambling bills were introduced, but all failed to pass due to "greedlock" (pro-gambling factions being unable to agree). The most comprehensive bill included a state-sponsored lottery, state-sanctioned casinos, a compact with the Poarch Creek Indians that would allow them to turn their current facilities into full-fledged casinos and build a new casino in Northeast Alabama, as well as legalizing online gambling and sports betting. The legislature may try again to pass a gambling bill in a special session or during the 2022 Regular Session, which begins January 11, 2022.

RETIREMENT ANNOUNCEMENT: ALCAP & American Character Builders executive director, Joe Godfrey, announced his plan to retire on April 30, 2022. A search committee has been at work and may have a successor named by October 1, 2021. This person will "shadow" Godfrey during the 2022 Regular Session of the Alabama Legislature and then take over as executive director upon Godfrey's retirement. Please be in prayer for both important ministries during these days of transition.

Samford is the top-ranked university in Alabama in national rankings published by *The Wall Street Journal*. Additionally, the *Wall Street Journal/Times Higher*

Education ranks Samford 2nd in the nation for student engagement. Samford is ranked 86th nationally for best value by U.S. News & World Report, and is the only Alabama university included in the list.

Samford University Highlights 2020-2021

- Samford achieved its 12th consecutive year of **record enrollment**, despite the challenges of the COVID-19 pandemic, with 5,729 students enrolled for the fall semester. Included in the totals are 2,153 graduate/professional students and 3,576 undergraduates representing 47 states, the District of Columbia, and 30 countries. The numbers reflect new individual records in terms of size and quality for both enrolled graduate students and the entering class of 971 freshman students.
- Samford's Board of Trustees elected Beck A. Taylor as the university's 19th president, effective July 1, 2021. Taylor succeeded Andrew Westmoreland, who retired after serving as president of Samford University since 2006. Taylor was recommended to the board by a 23-member presidential search committee following a six-month national search involving more than 80 nominations and applicants. Taylor comes to Samford from Whitworth University in Spokane, WA where he served as president since 2010. Taylor returns to Samford where he served as dean and professor of economics for Samford's Brock School of Business from 2005-2010. After earning his undergraduate degree from Baylor University with majors in economics and finance, Taylor was employed as an analyst for Andersen Consulting (now Accenture) in Houston, Texas. He went on to earn his M.S. and Ph.D. in economics from Purdue University. He and his wife of 28 years, Julie, have three children: Zachary, 25, Lauren, 22, and Chloe, 14.
- Samford's Ministry Training Institute afforded courses at 35 extension locations, adding new extension sites at Golden Springs Baptist Church in Anniston, Ruhama Baptist Church in Fort Payne, and continuing to reach other states with a new site at the Alpha Baptist Association in Tennessee. The MTI office processed about 1,600 enrollments through the extension network and online certificate programs, and awarded 84 Biblical Studies Diplomas and 40 certificates to students who finished our curriculum. Samford continues to offer our online Women's Leadership Certificate in partnership with the Women's Missionary Union.
- Samford Athletics, with 17 varsity sports in the NCAA Division I level in the Southern Conference, earned a 99% Graduation Success Rate by the NCAA, ranking No. 1 nationally. This year Samford won the prestigious Germann Cup, which goes to the top women's athletic program in the Southern Conference. This marks the third time Samford has won the award. Overall, Samford teams won a school-record nine Southern Conference championships this year, breaking the old record of eight set during the 2019-20 season.

University of Mobile

2021 Report to Annual Associational Meetings

Over 60 years ago, Alabama Baptists saw the need for a Baptist college in South Alabama. The Book of Remembrance in the University of Mobile archives contains the names of 6,413 individuals and 186 businesses that pledged over \$2 million to the original "Building the Campus Beautiful in the Deep South" campaign for Mobile College. On December 12, 1961, Alabama Gov. John Patterson signed the official charter, creating a college founded on the belief in Proverbs 9:10 that "The fear of the Lord is the beginning of wisdom, and knowledge of the Holy One is understanding." Today, the University of Mobile is a proud testament to the vision and commitment of Alabama Baptists who continue to support "Higher Education for a Higher Purpose." Our year-long Diamond Anniversary celebration culminates on December 12, 2021, when we invite Alabama Baptists to recognize University of Mobile Day and the thousands of graduates serving in churches and communities across the state and throughout the world. We are thankful for the Lord's protection during the past year and celebrate the return to a full schedule of activities and events for the 2021-2022 academic year. Prospective students and families are invited to attend UM Days to visit campus, meet faculty and students, and learn about academic programs. Students who visit campus and enroll may earn a \$2,000 Visit Day Scholarship. RSVP for a UM Day or schedule a private tour at **umobile.edu/visit**.

All are invited to the annual Scholarship Banquet on Oct. 26 featuring football legend Archie Manning. RSVP at **umobile.edu/banquet**. Homecoming will be held Oct. 1-3. The Alabama School of the Arts presents the annual Performing Arts Series, with Christmas Spectacular on Nov. 18-21 at Cottage Hill Baptist Church in Mobile. Over \$500,000 in grants and donations was raised for the new J.L. Bedsole Strength and Performance Center that opened in August, replacing the 35-year-old weight training room in Pharr Gym. The university continues to expand academic programs. A significant addition is the Doctor of Nurse Anesthesia Practice in the new School of Nurse Anesthesia. This program was fully accredited in June and enrolled its first class this August. Among other academic developments:

- The first doctoral degrees in the university's history were awarded in May 2021 the Doctor of Nursing Practice and the Doctor of Musical Arts in vocal performance. Graduation speaker was UM alumna Sarah Thomas, the first full-time female in NFL history and the first female to officiate a Super Bowl.
- The new Center for Christian Calling, formerly the School of Christian Studies, is preparing students for ministry with an emphasis on practical skills. Adjunct instructors include over a dozen pastors, missionaries, association directors and ministry leaders from Baptist life.
- University of Mobile Online Programs offers 3 fully online programs offered in a flexible 8-week format for college students of all ages. Visit umobile.edu/online for more.
- The Master of Athletic Training program enrolled its first class in June 2021.
- The Master of Music in music education prepares graduates to continue toward doctoral programs in music education.

The university's motto, "Know and Be Known," describes an environment in which students are known by their professors, and professors know their calling goes beyond teaching subject matter in a particular discipline. Alabama Baptists can be proud of the faculty who teach at their university. Summer of 2020 was definitely not "business as usual" for Shocco Springs. Campus was beautiful as always, but it was quiet. We missed the familiar sounds of constant multitudes of kids splashing in our Aqua Park on the lake and the cheers of students as they prepped for team activities. It was strange not to see groups of kids sprawled all over the grass in front of the chapel or on the rock walls near the stream, working on their daily Bible studies.

But this summer we have experienced a complete, 180-degree change! Campus has been overflowing with high energy and excited students, eager to return to the full camp experience of new friends, incredible recreational activities, and awesome worship time. In 2020, guest numbers dwindled to less than 25% of our normal numbers. However, guest attendance for 2021 is almost back to pre-Covid levels. We give God the glory as we rejoice over the consistent reports of how students and adults continue to be impacted in wonderful ways through the ministry of Shocco Springs.

Always looking for new ways to love and serve our community, we had a dream of sharing our part of God's magnificent nature with local children who might never have an opportunity to visit Shocco with a church or other group. So for the first time ever, this July Shocco held a week long Day Camp for children from 5 to 12 years old. When reservations opened, our camp spots filled very quickly and left a long waiting list of students. Camp was a success and we were able to minister to around 60 children from our local community, several who were able to attend due to scholarships. The children enjoyed exciting recreation, crafts, and fun activities while learning about the love of God through Bible study and worship time. Our desire is that this will begin a tradition that will expand and minister to hundreds of local kids each summer.

God has been faithful to Shocco and we are committed to faithfully serving Him as we continue to welcome the thousands of people who visit our campus. The Board of Trustees and Shocco staff are deeply appreciative to Alabama Baptists for using our facilities, praying for us, partnering financially, making contributions of time and talent, and especially with gifts through the Cooperative Program. How Does the Cooperative Program Work?

It begins with you!

You give yourself first to God (<u>II Cor. 8:5</u>). This is commonly called a tithe and represents ten percent of your income (<u>Lev. 27:30</u>, <u>Mal. 3:10</u>).

Your church decides the next step.

Every year your church prayerfully decides how much of its undesignated gifts will be committed to reaching people in your state and around the world through The Cooperative Program. This amount is then forwarded to your State Board of Missions.

Messengers at the Alabama Baptist State Convention Annual Meeting...

from your church and other churches across Alabama decide what percentage of Cooperative Program gifts contributed by local congregations is forwarded to the SBC for North American and international missions and ministries. Alabama sends 50%.

Messengers at the Southern Baptist Convention Annual Meeting...

from across the country decide how the gifts received from the states will be distributed among SBC entities. These gifts are used by SBC entities to send and support missionaries, train pastors and other ministry leaders; provide relief for retired ministers and widows; and address social, moral and ethical concerns relating to our faith and families.

In 2020...

even with the challenges presented by the COVID pandemic, Alabama Baptists gave \$37,558,354.85 through the Cooperative Program to support missions and ministries around our state, nation and world. This exceeded the budget of \$37,500,00. We praise the Lord for the faithfulness of His people!
