CERTIFICATE OF CORPORATION.

TO THE HONORABLE M.D.WIGGINS, JUDGE OF PROBATE OF MORGAN COUNTY, ALABAMA.

The members of the Morgan County Baptist Association at a meeting of its members held on the 11th day of February 1930, having adopted the following resolution, to-wit:

"WHEREAS, it is the desire and wish of the Morgan County Baptist Association, a religious organization to become incorporated under Chapter 274, Article 23, Section 7167 and 7168 of the code of Alabama, as amended by an act of the Legislature of 1927, General Acts of Alabama, page 83; and,

"WHEREAS, the members of the Morgan County Baptist Association have assembled in regular meeting for the purpose of taking such action as is necessary under the laws to become an incorporated body,

THEREFORE, BE IT RESOLVED by the members of the Morgan County Baptist Association in regular meeting assembled, that it is the desire and wish of such members to become an incorporated body under the laws of the State of Alabama; and,

BE IT FURTHER RESOLVED, that out of the membership of this Association there be elected three members as trustees of the corporation to be organized and that the following members of said Association be and they are hereby elected as trustees of said Association and of the corporation, to-wit: Rev. J.D.Pickens, W.T.Harris and J.H.Crow,

BE IT FURTHER RESOLVED that by the adoption of this resolution the membership of this association do express and signify their intention of becoming incorporated and the trustees of said Association are authorized and empowered to proceed with the filing of a certificate of incorporation in the Office of the Judge of Probate of Morgan County, Alabama.

THEREFORE BE IT KNOWN that the undersigned trustees duly elected at said meeting of the members of the Morgan County Baptist Association, do hereby make, declare and file this their certificate of incorporation in the Office of the Judge of Probate of Morgan County, Alabama, this being the county in which said corporation is to exercise its functions.

FIRST. The name selected and adopted by said corporation is the Morgan County Baptist Association.

SECOND. The names of the trustees of said corporation heretofore duly elected are Revrend J.D.Pickens, W.T.Harris and J.H.Crow, said trustees were elected to serve until the annual meeting of the Association in October, and are to continue to hold office for such a period of time, and until their successors are elected and qualified.

THIRD. The Morgan County Baptist Association is a religious organization for religious purposes and objects solely and for these purposes has and will acquire and own property, real and personal, which said property has and will be used for religious purposes and for advancing its cause in a religious way, and for no other purpose.

FOURTH. The undersigned having been duly elected trustees for the purpose of this incorporation, as above set out, do hereby file this certificate.
